## **NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a regular meeting at 18650 Clay Road, Houston, Harris County, Texas, 77084, said address being an office and meeting place of the District.

## The meeting will be held on Monday, January 10, 2022, at 6:00 P.M.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Public comments;
- 2. Review and approve minutes of the November 23, 2021, December 6, 2021, and December 13, 2021, Board of Directors meetings;
- 3. Consider the following related to issuance of the District's Unlimited Tax Refunding Bonds, Series 2022 (the "Refunding Bonds"):
  - a) establish parameters for sale of Refunding Bonds pursuant to Texas Government Code, Section 1207.007;
- 4. Approval of Preliminary Official Statement in connection with the issuance of the District's Refunding Bonds and authorize distribution of same;
- 5. Approval of an Order authorizing the issuance of the District's Refunding Bonds, including delegation of authority pursuant to Texas Government Code Section 1207.007; and approval of form of bond purchase agreement;
- 6. Authorize the District's consultants to proceed with the preparation of a final Plan of Financing in connection with the Refunding Bonds;
- 7. Approval and execution of a Paying Agent/Registrar Agreement in connection with the Refunding Bonds;
- 8. Approval and execution of an Escrow Agreement with Regions Bank in connection with the Refunding Bonds;
- 9. Authorize the completion and distribution of a Final Official Statement in connection with the Refunding Bonds;
- 10. Authorize subscription for and purchase of U.S. Government Securities (state and local government series or open market securities) in connection with the issuance of the Refunding Bonds, if applicable;

- 11. Authorize bookkeeper to issue wire for Attorney General's fees;
- 12. Authorize execution of various additional documentation for inclusion in the transcript of proceedings to be submitted to the Attorney General of the State of Texas;
- 13. Authorize designated Board officer(s) to:
  - a) execute Pricing Certificate and Bond Purchase Agreement relative to the Refunding Bonds;
  - b) authorize disbursement of bond proceeds relative to the Refunding Bonds;
  - c) authorize execution of closing documentation relative to the Refunding Bonds;
  - d) authorize execution and filing of Internal Revenue Service reporting forms relative to the Refunding Bonds;
  - e) authorize District's disclosure counsel to file material events notice relative to bonds to be refunded by the Refunding Bonds; and
  - f) Such other matters and take any necessary action relating to the issuance of the Refunding Bonds;
- 14. Tax Assessor-Collector's Report, including authorizing payment of invoices presented, approve moving accounts to uncollectible roll and status of delinquent tax accounts;
- 15. Report and legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, and filing of proofs of claim;
- 16. Operation and Maintenance Report, including:
  - a) Authorizing the repair and maintenance of District facilities and property, including:
    - i) Replacement and/or testing of water meters in the District;
  - b) Consider referral of accounts for collection and approve write-off of uncollectible accounts; and
  - c) Appeals of District charges;
